In a nutshell, the product has three main functions, but within those the options are extensive.



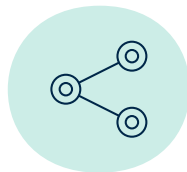
A powerful and extensive knowledge hub

A high-level overview

- substantive patent law aspects, with a focus on the life sciences.

Below is a high-level summary of the content covered in Irides:

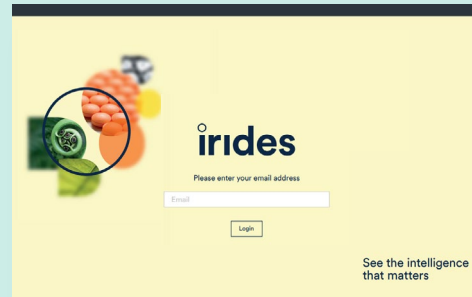
- Main legislation and guidelines pertaining to patent litigation and an overview of how patent disputes are conducted in each jurisdiction.
- Pre-action matters, such as notice letters, the availability of protective briefs, search and disclosure orders, and guidance on preliminary injunctions and other interim relief.
- Process for pursuing a main action, from choice of forum, standing, service, through timelines for an action, estimates of fees/costs and evidentiary/disclosure requirements, to relief, costs orders and enforcement. Also the effect of EPO/foreign proceedings on national courts.
- Grounds, procedure and timelines for appeals.
- Requirements and procedure for post-grant patent amendment.
- Alternative dispute resolution, settlement and withdrawal of proceedings.
- Substantive patent law, including infringement issues (e.g. claim construction, scope, doctrine of equivalents, defences to infringement and liability); and validity (e.g. grounds of revocation, patentability requirements of novelty, inventive step and industrial applicability, exclusions from patentability, sufficiency, clarity and entitlement issues).
- Related fields, including utility models, regulatory and associated competition law issues.

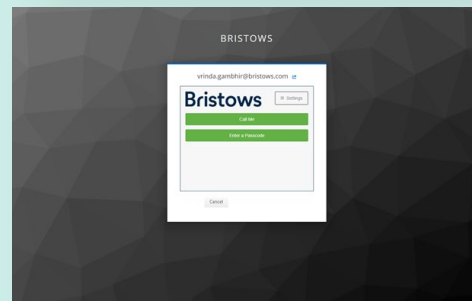

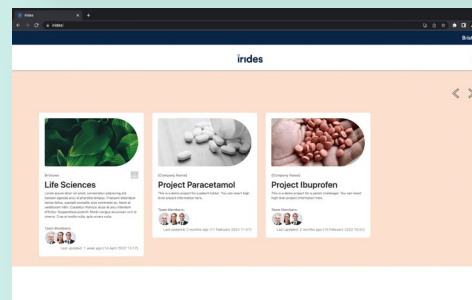
Accessibility

Irides is a web-based application. Simply go to the URL to see the intelligence that matters.



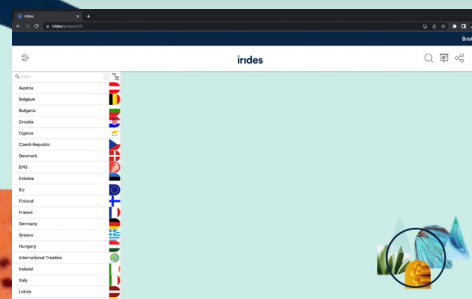
Security

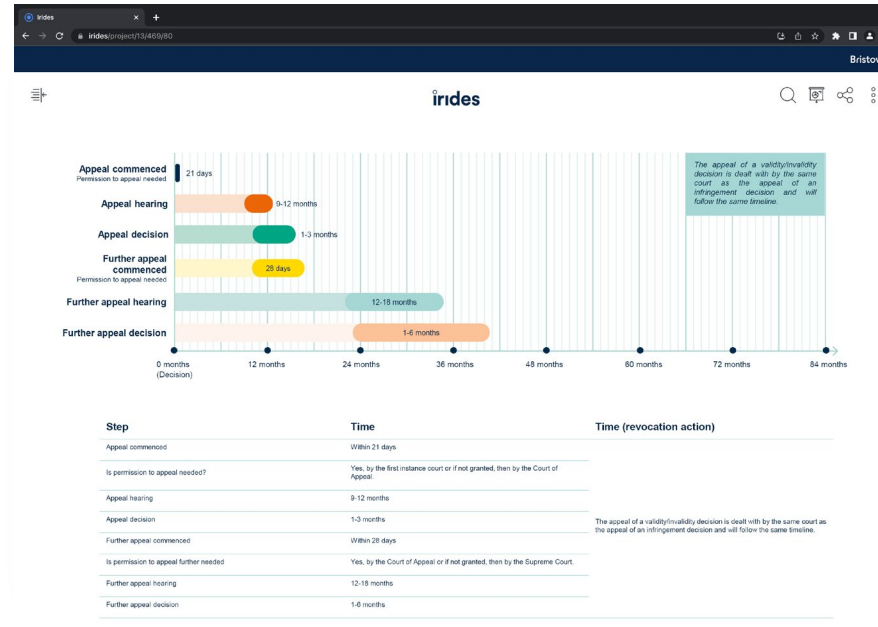

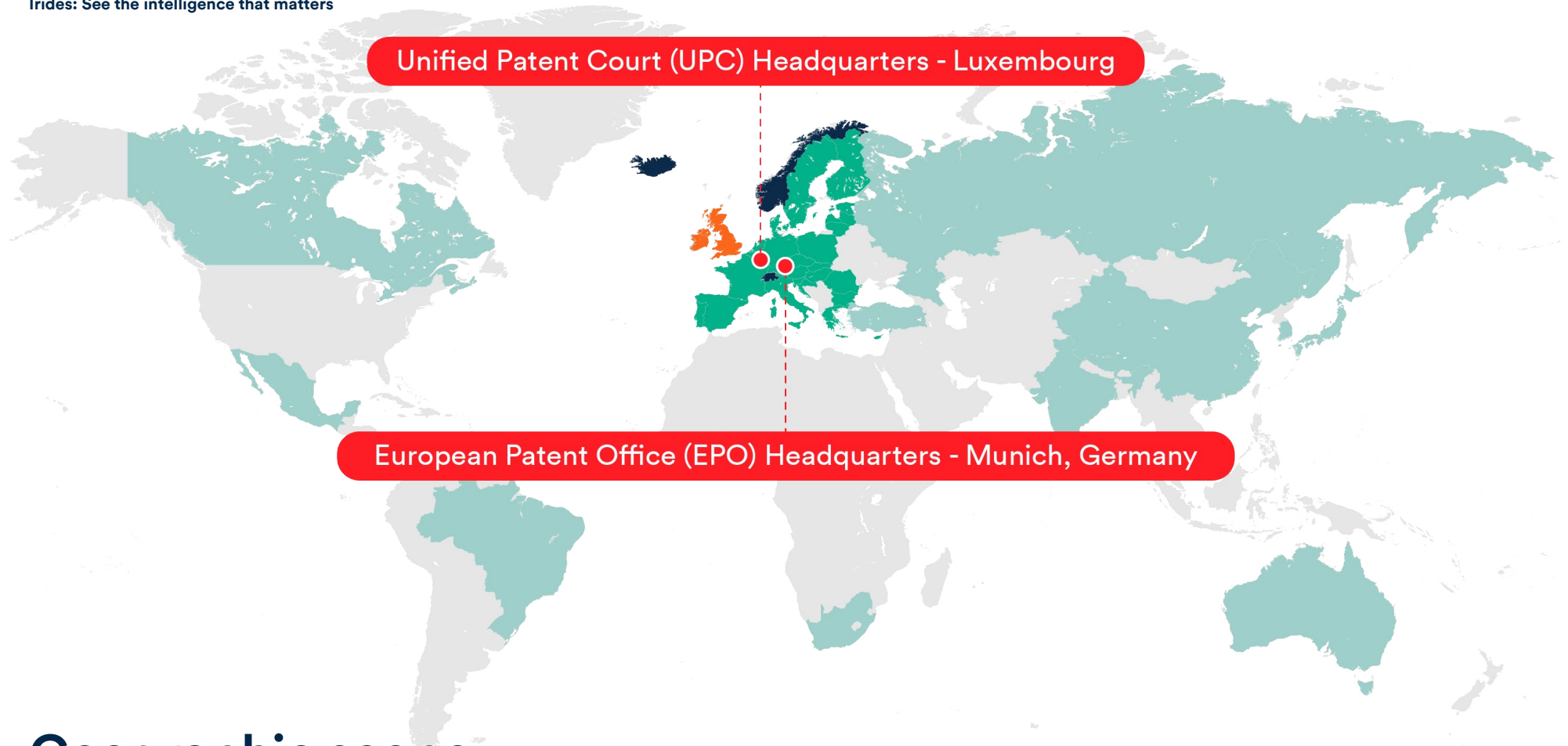

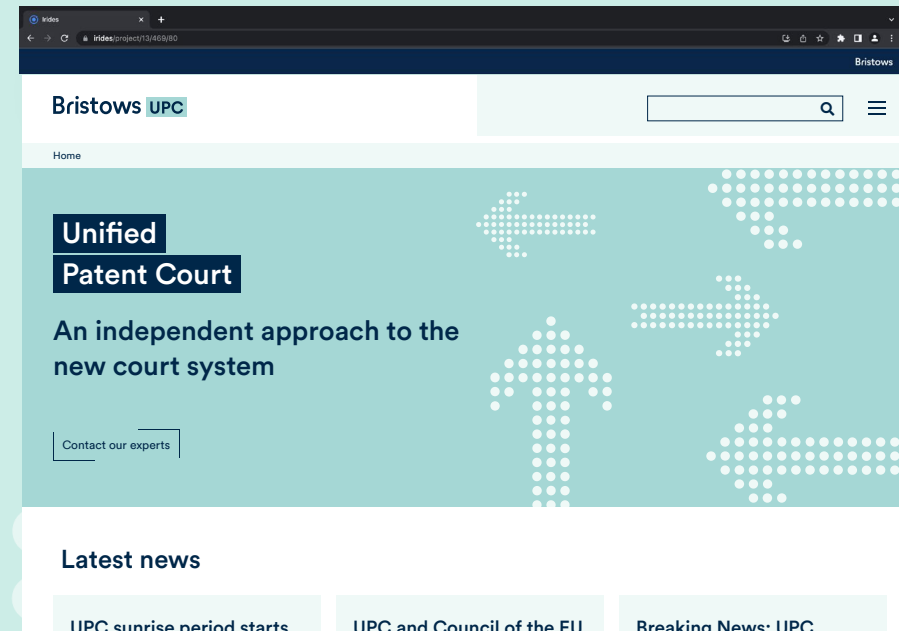
